- 1. Review action items and minutes of last meeting**

- Action Items:
 - Election Result Ratification Announcement has been made
 - Voting Rules Review Sub-Committee has been formed
 - Confirmed meeting dates of Macau 2015 has been updated on the website as well as to IGF secretariat
 - Call for Themes & Workshop Announcement draft and timeline have been circulated and revised. The call has been opened.
- The minutes of 29 Oct meeting has been reviewed and adopted.

2. Preparation for Macau 2015 Meeting

- **Updates from Local Host**
 - Local host will apply the International Meeting and Trade Fair Support Program(https://www.economia.gov.mo/public/docs/EAD_IMTF/en/terms_conditions.pdf) from the Macau Government. The funding will be applied under the co-locating event CommuniMacao 2015 with certain funding amount allocated for APrIGF 2015 because CommuniMacao has been organized the for several years with established scale and reputation which enhance the funding possibility.
 - Important points to note:
 - ❖ In order to apply for the funding and reimbursement, ALL participants would have to make a self-declaration as a qualified industry operator and submit necessary documents before 18 May 2015. More details will be provided later with templates.
 - ❖ The max. subsidized amount for each qualified participant will be MOP1,800 per night (Maximum 4 nights), inclusive of service charges and taxes from Jul 1-6. Transportation support could be up to 75% of the transportation expenses subject to the following maximum limits: " Departure from within Asia: MOP7,000 " Departure from outside Asia: MOP15,000.
 - ❖ Part of the government funding received will be used to cover the whole meeting expenses in order to make the event happen. A Travel Support Funding Application Process will be set up separately with specific subsidizing amount and quota decided according to the budget limitations.
 - ❖ Receipts of the flight tickets of each participants will have to be collected at the event dates for the funding process.
 - ❖ An opt-out choice maybe given to participants who are uncomfortable with the self-declaration.
 - Paul has raised concerns on the actual logistics in collecting the necessary documents on-sites. Edmon replied that the secretariat will further discuss with the local host on the process and ensure a smooth procedures. Counter will also be set up at the hotel venue to collect the necessary documents.
 - PengHwa has enquired about the pre-event possibilities. The secretariat replied that pre-event proposal is accepted through the online submission form as well with meeting rooms availability flexible at the moment.

- Interpretation – Hong asked whether there will be mandarin available while cantonese is the main spoken language in Macau, the secretariat and local host will further discuss and explore the possibility depending on the budget. The interpretation might considered to be for opening or plenaries only or specific to one room for all sessions that involved Chinese speakers.
- **Call for Themes and Workshop Proposal**
 - The call has been opened on 13 Nov 2014 with the thematic suggestion deadline remains 4 Dec 2014 and the workshop proposals deadline extended to 11 Mar 2015.

 - MSG members are requested to spread the news and share to their network and are encouraged to start discussing about the themes of 2015 in order to finalize it during the Dec meeting.
 - The secretariat has proposed to publish all the workshop proposals upon receiving the submissions instead of the approved workshops at a late stage. The suggestion was supported by Jia-Rong and no objections from other MSG members.
- **Travel Support Application Process**
 - It is proposed and agreed that a separate Travel Support Committee will be set up to determine and handle the Travel Support Application Process with transparency.
